7. PUBLIC HEARING PROTOCOL

- J. The project proponent is given an opportunity to present a rebuttal. After all testimony has been given, the Chair will close the public hearing and the Commission will discuss the matter. During this discussion, Commission members may individually ask questions of the project proponent, opponent, or staff, at the convenience of the Commission.
- K. The Chair will entertain a motion and a second.
- L. The Commission will discuss the question.
- M. The Commission will render its decision

The proposed project is for a conditional use permit to construct a security guard/caretaker's residence subject to Siskiyou County Code section 10-6.4703(q). The project would allow the continuous on-site security and supervision of applicant's facility. The project site is located at 210 Ski Village Drive Near the City of Mt. Shasta; Assessor's Parcel Number APN 037-140-090; Township 40 North, Range 4 West, Section 9.
