OF THE SISKIYOU COUNTY BEHAVIORAL HEALTH SERVICES BOARD

Members of the Siskiyou County Behavioral Health Services Board met on this 20<sup>th</sup> day of November, 2023 in person. Secretary Hargrove called the meeting to order at 3:35 p.m.

#### **Roll Call**

Board Members Chairperson Ed Harris, Supervisor Nancy Ogren, Lise Rogers, Earl Chancellor and Paul Contreras were present. Dee McGuffey were absent.

**Oral Comments from the Public on Non-Agenda Item:** None

**Minute Approval:** Ogren motioned to approve the Minutes from November 20, 2023 Contreras seconded. *Ayes: Harris, Ogren, Chancellor, Rogers, Contreras* *Nays: None* *Abstain: None*

**Oral Comments from the Board on Non-Agenda Item:** Harris requested information on the partially fenced property adjacent to the Behavioral Health Building, specifically if the homeless encampment would be moving there. Collard explained that moving the encampment was brought up at a CoC meeting and that was the end of BH involvement. Ogren explained that the City of Yreka stated that it was an immediate need and she informed Yreka that it would need to be proposed to the BOS, not the CoC committee. The BOS is viewing this as a non-critical need and can be brought back up in the Springtime. Additional discussion on State funding for LPS and CARE Court.

**Department Update:** Dr. Collard provided an update on the Mobile Crisis program that starts in January 1. MHSA funding is moving away from Preventative components and more toward housing. MHSA funding will now encompass SUD services and a presentation to the BOS on this item is expected to be presented in January.

*Action Item: Dr. Collard to review the BOS presentation with the BH Advisory Board once completed.*
