# RESOLUTION OF THE SISKIYOU COUNTY BOARD OF SUPERVISORS PROCLAIMING MAY 2024 AS MENTAL HEALTH AWARENESS MONTH IN SISKIYOU COUNTY

The following resolution is hereby offered and read:

WHEREAS, mental health is vital to everyone's overall health and well-being; and

WHEREAS, half of the population will experience some type of mental health challenge over the course of a lifetime; and

WHEREAS, every day millions of people face stigma related to mental health; and
