Dr. Thomas Harter, UC Davis, and the consulting team, Larry Walker Associates (LWA), are supporting the efforts to revise the GSP to address DWR's comments. LWA and Dr. Harter will provide updates on the revision status and schedule for completion. This item may include possible direction from the Committee on next steps.
