Ms. Jereb told the Commission that because of changes made at the Board of Supervisors level regarding offering Zoom for public participation in meetings, LAFCo staff wanted feedback from the LAFCo Commissioners regarding whether or not to offer Zoom at future LAFCo meetings.

Commissioner Valenzuela said he was in favor of not offering Zoom for routine meetings since the public often doesn't participate. However, he thought Zoom could be offered if there were a project on the Agenda that was significant enough in which public participation was anticipated.

Commissioner Cook said she thought it was good to have the Zoom option but it's also difficult to hear the meeting through Zoom. She said she can go either way.

Commissioner Mazzoni said he agreed with Commissioner Valenzuela.

Commissioner Cook wanted to know what items would require a meeting, and Ms. Jereb said staff is currently working on the Municipal Service Reviews and Sphere of Influence for the fire protection districts and agencies. She wasn't sure when it would be complete, but it will likely require at least three concurrent public meetings requiring public participation. Ms. Jereb added that was all that she was aware of unless something comes up requiring presentation to the LAFCo Commission.
