## Notice of Public Hearing

**Notice is Hereby Given** that the Siskiyou County Local Agency Formation Commission (Siskiyou County LAFCo) will hold a Public Hearing on **Tuesday, May 14, 2024, at 9:00 a.m.** in the Board of Supervisors Chambers, 311 Fourth Street, 2<sup>nd</sup> Floor, Yreka, California, on the project described below.

### Siskiyou County LAFCo Final Budget for Fiscal Year 2024/2025

Pursuant to California Government Code Section 56381, Siskiyou County LAFCo will consider and adopt its final budget for fiscal year (FY) 2024/2025. It is anticipated that adoption of the final budget for FY 2024/2025 will be determined to be a government fiscal activity or funding mechanism which do not involve any commitment to any specific project which may result in a potentially significant physical impact on the environment and is therefore not a project under the California Environmental Quality Act (CEQA) pursuant to Section 15378(b)(4) of the CEQA guidelines.

Siskiyou County LAFCo's proposed budget documents for FY 2024/2025 are on file in the Siskiyou County LAFCo office which is within the Planning Division of the Siskiyou County Community Development Department, 806 South Main Street, Yreka, California, 96097, and are available for public review upon contacting the staff planner. A staff report and all attachments will be available for public review three working days prior to the LAFCo meeting either at the Siskiyou County LAFCo office or online on the Siskiyou County LAFCo [meeting page](#).

All items presented to Siskiyou County LAFCo during a public hearing, including but not limited to, letters, e-mails, petitions, photos, or maps, become a permanent part of the record and must be submitted to the Clerk of the Commission. It is advised that the presenter bring 12 copies of anything presented to the Commission and that the presenter create copies in advance for their own records.

All public records related to an open session item on the Agenda which are not exempt from disclosure pursuant to the California Public Records Act that are distributed to a majority of the legislative body will be available for public inspection at 806 South Main Street, Yreka, CA 96097, at the time that the public records are distributed or made available to a majority of the members of the legislative body.
