Re: Compliance Filing with Ordering Paragraph (N) of License Surrender Order; Owner's Dam Safety Program for Lower Klamath Project, FERC Project No. 14803-001

Dear Secretary Bose:

On December 2, 2022, the co-licensees adopted PacifiCorp's existing Owner's Dam Safety Program with respect to the Lower Klamath Project¹ for the time period *before* the Facilities Termination Date.² Now, on behalf of the co-licensees, the Klamath River Renewal Corporation (Renewal Corporation) submits the Owner's Dam Safety Program to be in effect after the Facilities Termination Date for each Facility in compliance with Ordering Paragraph (N) of the Commission's License Surrender Order.³ The co-licensees are concurrently submitting two hard copies of the Owner's Dam Safety Program to the Commission's Division of Dam Safety and Inspections – Portland Regional Engineer.

The enclosed Owner's Dam Safety Program complies with part 12, subpart F, of the Commission's regulations (18 C.F.R. § 12.60 et seq.). The Program also explains the interrelationship between the co-licensees regarding dam safety issues and includes the name and resume of the Renewal Corporation's Chief Dam Safety Engineer, who will be the individual


