### Camping Administrative Permit <u>Effective: November 15, 2017</u>

In furtherance of the health and safety of Siskiyou County residents and the protection of private property within the County, the Siskiyou County Board of Supervisors has passed an ordinance standardizing and regulating camping on private property outside of designated campgrounds.

# Siskiyou County Code (SCC) Section 3-17.01 – Camping on Private Property Outside Designated Campgrounds.

Effective November 15, 2017, it shall be unlawful and a public nuisance within the unincorporated areas of the County to camp or squat upon private property without a legally established residence, on private property that is outside of a designated campground, or on a property with other lawful entitlements to camp unless such person has been issued a permit to do so by the County Planning Division.

#### Permit Issuance and Requirements

An administrative permit to camp outside designated campgrounds on private property that does not have a legally established residence shall be issued by the Planning Director upon application by a property owner for a period not to exceed fifteen (15) days, subject to compliance with all of the following:

- 1. At the termination of the term of camping, all tents and temporary structures or shelters shall be removed from the subject property.
- 2. At the termination of the term of camping, all garbage, trash, or other waste shall be removed and properly disposed of.
- 3. All use of camp fires or burning shall be in compliance with this code and state law, and pursuant to any required permits.

#### Permit Renewal

The Planning Director may renew or reissue an administrative permit to camp one or more times in a calendar year, so long as the cumulative period of camping authorized on the subject property does not exceed thirty (30) days in one calendar year.

#### Violations

It is the County's intent to enforce compliance with the Siskiyou County code. For this purpose, all violations may result in the County proceeding with the legal actions necessary to obtain compliance; the County may pursue any Criminal, Civil, and/or Administrative action it deems warranted.
