Project Description: The Siskiyou County Sheriff's Office is requesting bids for the purchase of ten (10) New Police-Rated Patrol Trucks or SUVs of any make.

General Information:

- 1. Ten (10) New Police-Rated Patrol Trucks or SUVs (any make)
 - a. Tow Package
 - b. 4 Wheel-Drive
 - c. Plug and Play/Electrical Connectors

The County is seeking quotes for any makes and models of Pursuit/Police rated vehicles that include a Tow Package, Four-Wheel Drive, and the Plug and Play/Electrical Connectors. All other remaining specifications are at the respondent's discretion to provide, but should generally consider those that would provide for the fastest delivery to the County.

Please include delivery date of vehicles in the bid. The County will accept bids of fewer than the total of ten (10) New Police Vehicles requested and reserves the right to contract with multiple vendors in order to acquire the total amount needed.

The County of Siskiyou reserves the right to reject any or all bids and to waive any irregularities in the bidding.
